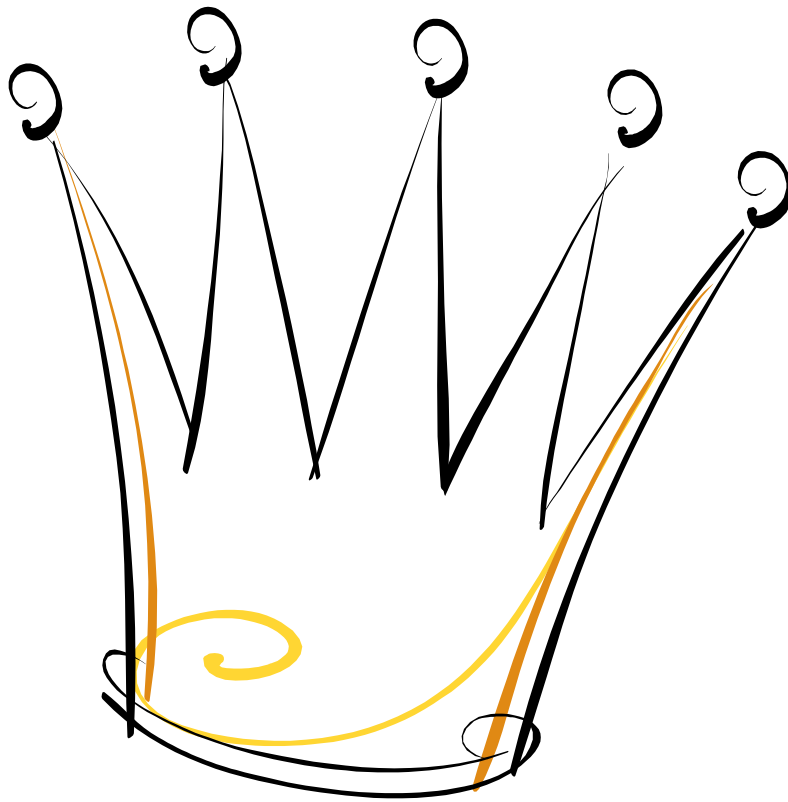

# Louisa County Fair Princess Program Information

## ★ Selection of Princess

The judges selected to judge the Louisa County Fair Queen & Jr. Queen Contest will also judge the Princess Program based on the application provided, short interview as well as onstage competition in party dress. One winner will be crowned, no runners-up.

## ★ Who can be a Princess

Any young lady ages 4-8 years old at the time of the contest who lives or attends school in Louisa County.

## ★ Registration & Applications

Princess contestants must complete **Online Registration Form**, submit their paperwork packet (email is preferred), and pay an entry fee either via the Online Registration Form or with their paperwork. The ENTRY FEE (\$35) should be made payable to LCFQC by the **entry deadline of JUNE 20<sup>th</sup>**. Parents may assist in the completion of the packet. They can be typed or handwritten but must be legible.

## ★ Entry Fee

The \$35 entry fee pays for tiaras, sashes, certificates, crown & prize. There will be an additional \$25 fee on all returned checks. Make payable to *Louisa County Fair Queen Contest or LCFQC*.

## ★ Photos

Each Princess contestant must submit a head and shoulder photo (color). The photo must accompany application packet and entry fee or **emailed** as jpg or png file (digital files are preferred). Photo does not have to be professional.

## ★ Dress Requirements

Each Princess contestant is to provide her own dress for the party dress competition. The dress can be any color, but the length of the dress should fall below the knee and above the ankle, so it is easy for the contestant to walk in. Minimal beading/sequins is preferred.

## ★ Tiaras and Sashes

The Louisa County Fair Princess Program provides tiaras and sashes to every participant. The tiara & the new Princess's crown are not toys and should be handled with care. They should only be worn during official events, competition & then may be worn during the fair as a Princess Participant or as the new Princess. If the tiara/crown is broken, a replacement will not be provided.

## ★ Rehearsal & Competition

Princesses will need to participate in a rehearsal/orientation prior to competition. Interviews will be held the day of competition. The day of coronation, the contestants should arrive ½ hour prior to start time at the fairgrounds. Specific details given after entry.

## ★ Hair & Make-up

For the interview, natural hair away from their face is preferred and **absolutely NO make-up!** For onstage party dress, may have hair styled/up and may use **only** blush or lip gloss - otherwise no make-up!
